## RULES AND REGULATIONS – Meat Goat Department

1. A 4-H or FFA member must be enrolled in a goat or veterinary science project to enter the Meat Goat Department at the Fair.
2. Exhibitors must comply with the 2024 regulations as set forth by the Maryland Department of Agriculture – Animal Health Section. Exhibitors must present the approved animal health certificate prior to taking animals from the truck or trailer at the fairgrounds.
3. All exhibitors are expected to follow all 4-H and FFA rules, include the Exhibitor Code of Conduct, Animal Ethics and Welfare, General Fair rules, Livestock Sale Committee rules and Department rules for each specific species being exhibited by 4-H and FFA exhibitors.
4. All 4-H and FFA members who exhibited a market livestock project at the 2023 Carroll County 4-H/FFA Fair will be **REQUIRED** to submit a 2023 4-H Project Record for each species exhibited (FFA members must submit a completed FFA Record Book) in order to be eligible to sell a market animal at the 2024 Carroll County 4-H/FFA Livestock Sale.
5. The fitting and preparation of all goats is the responsibility of the exhibitor. Exhibitors may receive guidance from immediate family members, other Carroll County 4-H & FFA youth and appointed MCE volunteers or FFA advisors. Violation of this policy may result in immediate disqualification of the animal from all 4-H/FFA livestock shows and competition at the Carroll Co. 4-H/FFA Fair and possible dismissal from the fairgrounds.
6. Feeds and supplements approved for livestock use may be used by exhibitors. If an exhibitor feels their animal is in need of electrolytes due to health concerns of the animal, they may be administered by a recommendation of a veterinarian by the veterinarian, and in the presence of the Department Superintendent, the Livestock Area Superintendent or one of the Livestock Area Assistant Superintendents.
7. Any champion/champion challenge may NOT show another exhibitor's animal. Exhibitors with more than one animal in a class may have assistance, but exhibitors must be within the same 4-H age division or younger.
8. When an animal is in need of veterinarian care while on the Fair Grounds the Department Superintendent must be notified. When an animal requires veterinary treatment while at the Fair, you may use the veterinarian on the grounds at your cost, call your veterinarian at your cost or remove your animal from the fair.
9. All exhibitors must be available for housekeeping duties throughout the Fair. It is the responsibility of the exhibitor to clean pens, and to water and feed their animals before 10:00 am when the fair opens to the public. **ALL ANIMALS MUST HAVE CLEAN FRESH WATER AVAILABLE TO THEM AT ALL TIMES!**

## MARKET GOATS

1. All market goats must be owned by May 1, 2024. Exhibitors may identify six animals – four may be exhibited.
2. All horns must be tipped/rounded or removed and will be inspected by a committee member.
3. All male market animals must show signs of castration before tagging date.
4. All 4-H meat goats must be positively identified as project animals. Scrapie ID tags are required.
5. Both wethers (neutered males) and does may be shown in the Market Goat classes. No intact males will be allowed in any market class.
6. All market goats must be weaned at least two weeks prior to the Fair.
7. The Grand Champion Market Goat MUST sell at the Livestock Sale.
8. Market project animals will be mouth checked at tagging for the presence of milk teeth. Goats showing eruption of either or both of the first pair of permanent teeth will not be tagged; mouths will be re-checked at weigh-in. Any goats showing either or both of the first pair of permanent teeth will not be shown.
9. Market Goats must have a Rate of Gain of .20 pounds per day and weigh 70 pounds or more to be eligible for the Livestock Sale.
  - i. If you only have one market goat and it does not make rate of gain or sale weight you will be able to show in the exhibition class. **The exhibition class is only for exhibitors who do not have any market goats that make rate of gain or weight (70 pounds or more). Only one market goat per exhibitor may be entered in the exhibition class. These market goats will not be eligible for the Grand Champion drive.**
  - ii. The exhibition classes will occur prior to the show.
10. Market Goat exhibitors should be present at time of weigh-in. Animals will be placed in weight classes following weigh-in at the Fair.
11. There will be four (4) weight divisions champions and reserve champions selected during the show that will compete for the Grand Champion and Reserve Grand Champion Market Goat at the completion of the individual classes. Only market goats that make the sale weight and rate of gain will be eligible to be in the Grand Champion Drive.
12. The weight divisions will be as follows: Light weight market goat 70-79lbs, Medium weight market goat 80-89lbs, Light Heavy weight market goat 90-99lbs and Heavy weight market goat 100+ lbs.
13. Show officials may disqualify any animal that does not meet the weight stipulations or that has not been properly cared for.
14. Animals showing current signs of a contagious, infectious disease, pronounced defect or abnormalities, or abnormal abscesses will not be allowed on the fairgrounds.
15. Market goats will be divided into classes by weight, not breed. All breeds will be shown together.
16. Goats must be shown with a collar. No pronged collars **will** be allowed. Leather goat show halters are acceptable.
17. All market goats (wethers and does) must be slick shorn (less than 3/8" hair above knees and hocks, excluding tail switch). **This must be done prior to arriving at the fairgrounds.**
18. Only ONE animal may be exhibited in the bred and owned classes. Embryo transplanted animals will be considered bred and owned only when the **exhibitor owns both the donor dam and the recipient dam prior to conception.** If the conception was natural or artificially inseminated, the exhibitor must own the dam prior to conception.

19. During the show, goats must have all four feet firmly on the ground when being braced. The front legs may be picked up for the purpose of setting the feet but must be immediately set back down. When the judge is handling the goat, the goat's hooves must be placed on the ground.
20. The 4-H and FFA show ring code of ethics requires that only humane management, fitting, showing, and handling practices are acceptable. No topical products of any kind may be used such as, but not limited to Cool pack covers and cool towels, adhesives, conditioners, icing, ramping, slapping, punching/inhumane treatment, or use of alcohol products are PROHIBITED. NO ARTIFICIAL COLORING MAY BE USED ON ANY PART OF THE ANIMAL.
21. Drenching is not permitted the Carroll County 4-H & FFA fair at any time except if it is authorized by a veterinarian AND supervised by one of the Superintendents of the department.
22. Meat Goats are to be walked in the Meat Goat area of the barn only.

## **RATE OF GAIN**

- Rate of Gain will be paid on market goats achieving:

Blue Award - \$3 (.35 lb. per day and above); Red Award - \$2 (.25 - .34 lb. per day); White Award - \$1 (.05 - .24 lb. per day)

## **MEAT BREEDING GOATS**

1. All breeding goats must be permanently identified by registration tattoo and have the original registration certificate or Maryland 4-H ear tag. Non-registered (commercial) breeding animals must be tagged at market animal tagging **as a commercial breeding project** and have a scrapie tag.
2. Exhibitors may enter no more than two animals per breeding class.
3. Horns must be tipped/rounded and will be inspected by a committee member.
4. Breeding animal classes are for does and bucks. Animals shown in the breeding classes must be owned prior to June 10, 2024.
5. Does may be shown in either the breeding or market goat classes, but not both.
6. Meat Goats are to be walked in the Meat Goat area of the barn only.
7. Only one animal per exhibitor may be shown in the bred and owned division. Embryo transplanted animals will be considered bred and owned only when the **exhibitor owns both the donor dam AND the recipient dam prior to conception/transplantation**. If the conception was natural or artificially inseminated, the exhibitor must own the dam prior to conception. Registered Breeding Papers: THE EXHIBITOR MUST BE LISTED AS THE BREEDER.
8. Dam and Daughter: The daughter (doe) must be the offspring from the biological dam. **Both must be shown together in the class.**
9. During the show, goats must have all four feet firmly on the ground when being braced. The front legs may be picked up for the purpose of setting the feet but must be immediately set back down. When the judge is handling the goat, the goat's hooves must be placed on the ground.
10. The 4-H and FFA show ring code of ethics requires that only humane management, fitting, showing, and handling practices are acceptable. No topical products of any kind may be used such as, but not limited to Cool pack covers

and cool towels, adhesives, conditioners, icing, ramping, slapping, punching/inhumane treatment, or use of alcohol products are PROHIBITED. NO ARTIFICIAL COLORING MAY BE USED ON ANY PART OF THE ANIMAL.

11. Goats must be shown with a collar. No pronged collars will be allowed. Leather goat show halters are acceptable.
12. Drenching is not permitted at the Carroll County 4-H & FFA fair at any time except if it is authorized by a veterinarian AND supervised by one of the Superintendents of the department.

## **FITTING AND SHOWING REGULATIONS**

1. Participation in fitting and showing is MANDATORY for all exhibitors showing a market goat, except for previous champions/champion challenge. If an exhibitor only shows a breeding animal it is up to the discretion of the exhibitor however, due to space limitation it MUST BE approved by the superintendents. If using a breeding doe, the doe must be UNDER THE AGE OF ONE YEARS OLD. No intact males will be allowed in any fitting and showing class.
2. There is no novice class. Exhibitors will show within their 4-H age division. There are no clover classes.
3. During the show, goats must have all four feet firmly on the ground when being braced. The front legs may be picked up for the purpose of setting the feet but must be immediately set back down.
4. Goats must be shown with a collar. No pronged collars will be allowed. Leather goat show halters are acceptable.
5. The 4-H and FFA show ring code of ethics requires that only humane management, fitting, showing, and handling practices are acceptable. No topical products of any kind may be used such as, but not limited too Cool pack covers and cool towels, adhesives, conditioners, icing, ramping, slapping or use of alcohol products are PROHIBITED. NO ARTIFICIAL COLORING MAY BE USED ON ANY PART OF THE ANIMAL.
